

Terms and Conditions

Agreement between User and ymovement.net

Welcome to ymovement.net. The ymovement.net website (the "Site") is comprised of various web pages operated by YMovement LLC. ymovement.net is offered to you conditioned on your acceptance without modification of the terms, conditions, and notices contained herein (the "Terms"). Your use of ymovement.net constitutes your agreement to all such Terms. Please read these terms carefully, and keep a copy of them for your reference.

ymovement.net is an E-Commerce Site.

If a Profile is added to the Paying User's account, the Profile account can then view YMovement material. The YMovement website is geared toward providing information on what YMovement has to offer, a webpage for Users to sign up for services, online merchandise shop, landing page for all YMovement questions, and YMovement User Portal.

If a YMovement User's account is terminated for any reason, the aforementioned YMovement User's account will not be charged. All documents, resources, information, and data stored on user's account will be deleted after failure to complete monthly coach's payment.

If a YMovement User does not have a successful payment completed on the day of billing, YMovement LLC will reach out to YMovement User (through email) to discuss payment arrangement.

The arbitrator's award shall be final, and judgment may be entered upon it in any court having jurisdiction. In the event that any legal or equitable action, proceeding or arbitration arises out of or concerns these Terms and Conditions, the prevailing party shall be entitled to recover its costs and reasonable attorney's fees. The parties agree to arbitrate all disputes and claims in regards to these Terms and Conditions or any disputes arising as a result of these Terms and Conditions, whether directly or indirectly, including Tort claims that are a result of these Terms and Conditions. The parties agree that the Federal Arbitration Act governs the interpretation and enforcement of this provision. The entire dispute, including the scope and enforceability of this arbitration provision shall be determined by the Arbitrator. This arbitration provision shall survive the termination of these Terms and Conditions.

Class Action Waiver

Any arbitration under these Terms and Conditions will take place on an individual basis; class arbitrations and class/representative/collective actions are not permitted. THE PARTIES AGREE THAT A PARTY MAY BRING CLAIMS AGAINST THE OTHER ONLY IN EACH'S INDIVIDUAL CAPACITY, AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PUTATIVE CLASS, COLLECTIVE AND/ OR REPRESENTATIVE PROCEEDING, SUCH AS IN THE FORM OF A PRIVATE ATTORNEY GENERAL ACTION AGAINST THE OTHER. Further, unless both you and YMovement LLC agree otherwise, the arbitrator may not consolidate more than one person's claims, and may not otherwise preside over any form of a representative or class proceeding.
